



Rooted seeks two new board members

Good governance and sound supervision are essential to keep the quality of our programming high. That is why we have a clear strategy, code of conduct and an active supervisory Board. The Board of Rooted supervises the policy, sets financial guidelines and has final responsibility for all Rooted activities. The Board gives solicited and unsolicited advice. The Board consists of six people: a chair, a treasurer, a secretary and three general board members. The members are appointed by the Board itself.

The members of the Rooted Board do their work voluntarily, only expenses are reimbursed. The members are appointed for an indefinite term. We welcome a commitment of at least two years.

- The opportunity to contribute to the rooting and home-coming of people with a migratory background in the Netherlands;

- Preference will be given to people with lived migratory experience;
- Good level English and Dutch is desirable.
